ALERTS

- Between 1996 and 2020, Voting Age Population increased by around 35,000, a 28% increase
 - Registered Voters increased by around 53,000, a 57% increase
 - Ballots Cast increased by more than 46,000, a 71% increase

Where did all these additional Voters come from?

- The Registered Voter database experienced massive increases and decreases year to year:
 - 7,181 2002-2003 +15,806 2003-2004 +8,011 2007-2008 -4,562 2009-2010
 - 5,615 2010-2011 +5,616 2011-2012 -5,582 2018-2019 +9,366 2019-2020

Why the large differences in Registered Voters year-to-year when the Voting Age Population gradually increased by around 1,000 – 1,500 year-to-year?

- There were significantly more Ballots Counted in 2004 (+18,570) and 2020 (+10,474) compared to the previous presidential election. **Why the large spikes in votes in 2004 and especially in 2020 when COVID-19 consumed the daily lives of most everyone in the country?**
- Registered Voters compared to Voting Age Population increased 13% from 73% to 86% between the 1996 and 2000 presidential elections, which is in excess of population growth. This percentage increased further to 92% in 2008 and remained unnaturally high at 88% to 92% for all presidential elections between 2000 and 2020. **Are 9 out of every 10 citizens in Clermont County that are age 18 and older really registered to vote, or are phantom registrations distorting the true number of Registered Voters in Clermont?**
- Ballots Counted compared to Voting Age Population increased 11% from 53% to 64% between the 2000 and 2004 election, and remained at the higher level for the 2008, 2012 and 2016 presidential elections before spiking even higher at 69% on the 2020 presidential election. **Are the tremendous increases in Ballots from true Clermont County Registered Voters or are phantom votes manipulating elections in Clermont County?**

SUSPICIOUS VOTES IN CLERMONT COUNTY

11,483 NOV 3 2020 BALLOTS WERE CAST BY REGISTERED VOTERS WHO ARE VOTING FOR THE 1st TIME ON NOV 3 2020

There were 11,483 registered voters in Clermont County WHO VOTED NOV 3 but they have NO OTHER VOTER HISTORY for the past 20 years.

ALERTS:

- Around 50 of these Registered Voters who have not voted in the past 20 years, but voted NOV 3 2020 have Registration Dates earlier than the year 2014. **Since these people didn't vote for over 6 years, the voters should have been removed from the Registration Database prior to voting NOV 3 2020. Did a BMV transaction keep these people registered? Do all of these represent valid Voter Registrations?**
- Over 3,000 of these Registered Voters were more than 22 years old on NOV 3 2020, meaning they qualified to vote in one or more previous presidential elections, but chose not to.
- Many of these Registered Voters may have had their voter record and Registration Date updated with an address change by third parties, with or without the knowledge of the voter.
- Over 7,000 of these Registered Voters are young 1st time newly Registered Voters voting for the 1st time Nov 3 2020. That is a lot of votes in Clermont County coming from a demographic who generally do not have a high history of Voter Registration and Turnout.

INFLATED VOTER REGISTRATION DATABASE IN CLERMONT COUNTY

10,980 REGISTERED VOTERS HAVE VOTER STATUS “CONFIRMATION” ON DEC 4 2020 STATEWIDE VOTER REGISTRATION

A voter in “Confirmation” Voter Status legally registered to vote or updated their address with an Identification allowable by SOS. Clermont County follows up by sending a Confirmation notice to the newly Registered Voter or anyone who moved into another precinct within Ohio at the Residence Address on his/her Voter Registration/Change of Address application. This process is to verify the person physically lives at said address. However, the Confirmation card was not returned. The person can still vote Provisionally, Early at BOE or in person at the polls and present an SOS allowable identification. Once a person with CONFIRMATION Voter Status votes, the Voter Status is supposed to update to ACTIVE, but it appears this doesn’t happen uniformly as there are 30 people still in CONFIRMATION status on the DEC 4 2020 SWVR. (perhaps there were some Registered Voters who moved into Clermont following the NOV 3 2020 election and updated their Voter Registration AFTER the Nov 3 2020 election).

ALERT

- Notice the Registration Dates in the samples above. There are around 3,200 Registered Voter records with a Registration Date older than Jan 1 2014. Some go back to the 1950s and 1960s. These Registered Voters never did “CONFIRM” their new registration or change of address. They haven’t voted since before JAN 1 2014. **Why are they still on the voter rolls?** They meet the OEM Guidelines to be removed from the Voter Rolls, yet they have not been canceled. **Are BMV transactions renewing their Voter Registrations?** Their voter records are distorting the number of True Registered Voters, manipulating Voter Turnout % and are vulnerable for Voter Identity Theft.

INFLATED VOTER ROLLS IN CLERMONT COUNTY

58 SETS OF 2 or 3 POTENTIAL CLONED VOTER RECORDS

Potential cloned registrations have the same last name, date of birth, registration date and address. Only the first and middle names are different. It could be that Clermont County has a lot of twins or triplets that all live together and register to vote on the same date, or husband and wife who happen to have the same birthday and register to vote together, or there could be other nefarious actions happening.

- The total may also include new registered voters between Oct 6 and Nov 2 2020 that were not eligible to vote in Nov 3 2020 election.
 - In Clermont County, only 11 of the 457 new registered voters didn't vote Nov 3 2020
- The total may also include new registered voters to Clermont County from other precincts within Ohio.
 - In Clermont County, only 18 of the 457 new registered voters had previous voter history within the last 20 years, which would indicate they were previously registered in another county within Ohio.
 - In Clermont County, 445 out of 457 new registered voters VOTED NOV 3 2020.
- ***How is it possible that many of these new registered voters on Dec 4 2020 SWRV but not on Nov 3 2020 SWVR actually voted on Nov 3 2020? Where did all the rest of these new Voter Registrations come from?***

UNUSUAL CHANGES BETWEEN NOV 3 2020 SWVR AND DEC 4 SWVR IN CLERMONT COUNTY

- In Clermont County, there were **145 first and middle initial/middle name changes between the Nov 3 2020 SWVR and DEC 4 2020 SWVR**, changing formal first names to casual name or vice versa, changing middle initial to middle name and vice versa. The majority of changes were middle initial to middle name. Address stayed the same. Registration date changed to Nov 3 2020 on all but 6 voter records. Examples include:
 - **PETRIC, BRIDGET N** has registration date of **10/5/2020** on NOV 3 2020 SWVR
PETRIC, BRIDGET NUNEZ has registration date of 11/2/2020 on DEC 4 2020 SWVR
DOB on both SWVR is 10/14/1958
VOTED NOV 3 2020
NEVER VOTED BEFORE 2020 GOING BACK 20 YEARS
 - *Why register to vote on 10/5/2020 (or have address change processed that updated Registration Date and then update the registration less than a month later to change middle initial to middle name?)*
 - *Why was this 62 year old motivated to vote for the 1st time in 2020 and not motivated to vote in previous elections going back at least 20 years?*
 - *More investigation regarding this voter registration is needed.*
- In Clermont County, there were 2 voter records with no change in name, address or DOB, yet the registration date changed from the NOV 3 2020 SWVR to the DEC 4 2020 SWVR:
 - **CALAHAN, MARK D** has registration date 6/19/2018 on NOV 3 2020 SWVR
CALAHAN, MARK D has registration date 11/3/2020 on DEC 4 2020 SWVR
Address of 4153 West Fork Ridge Dr. Batavia is the same on NOV 3 & DEC 4 2020 SWVR
DOB of 7/5/1962 is the same on NOV 3 & DEC 4 SWVR
VOTED NOV 3 2020
VOTED IN PRESIDENTIAL ELECTION NOV 2016 but didn't vote in any other election going back 20 years. Since this vote was prior to NOV 3 2020 SWVR registration date of 6/19/2018, person likely moved from another address within Ohio in 2018 and was previously registered to vote.
 - *Why did the Registration Date change from NOV 3 SWVR to DEC 4 SWVR when it appears nothing changed on the voter record?*
 - *More investigation regarding this voter registration is needed: full voter record from SOS to include previous addresses and any triggers that caused a registration date difference between Nov 3 2020 and Dec 4 2020 SWVR.*

ALERTS

- When voting, pollworkers are trained to accept minor differences in the first and middle names when accepting identification, so *what is the purpose of all the changes in first and middle names between the NOV 3 2020 SWVR and DEC 4 SWVR?*
- *What is the source of all these first and middle name changes that happened between Nov 3 2020 and Dec 4 2020? Are they legitimate changes? Is there something nefarious going on?*
- This highlights the need for verification that the voter registration name exactly match identification to eliminate frivolous first and last name changes on the SWVR.

When a voter moves to a different precinct within Ohio, the end result is their Ohio Voter Id is supposed to remain the same, and they are assigned a new County Voter Id. In a properly functioning system, the old County Voter Id would be immediately canceled and all voter history is moved to the new County Voter Id.

There are a minimum of 97 cases (194 duplicates) in which the system did not work; there are two voter records for the same person with two different Ohio Voter Ids. The vast majority of these voter records have new registration dates older than the current month, in case county to SOS sync/merge happens once a month. Some go back to years 2013, 2014 2015 and 2016.

Why haven't these duplicate voter records been merged or canceled in all this time? At minimum, it inflates voter records and manipulates voter turnout. Think about all the new voter records that are created through Provisional Votes around Election Day when people have moved since they last voted. As worse, it allows bad actors to potentially cast ballots from both voter records as shown below.

Roseann Pastorie cast ballots from 2 different voter records on 11/3/2020.

January 1, July 4 and December 25 are federal holidays every year in which federal workers do not work, and no USPS mail is received. Between 1/1/1941 and 1/1/2017, there are **70** new voter registrations entered into the Voter Management System with a registration date of January 1, July 4 or December 25. Keep in mind, online voter registrations became effective in Ohio in 2017. In addition, **47** of these voters cast ballots on Nov 3 2020. ***Are these valid voter registrations? Are these valid votes counted?***

Beginning 1/2/2017 to 7/4/2020, there were 112 new voter registrations entered into the Voter Management System with a registration date of January 1, July 4 or December 25. 67 new voter registrations appear in the Voter Management System with a registration date of July 4 2022. ***If the Registration Date is based on the date Clermont County 'receives' and begins processing the registrations, how are they 'received' and processed on federal holidays when federal employees do not work?***

Why are there 35 new voter registrations on July 4 2022? There were 1111 votes cast in the Nov 3 2020 election from the 182 voter registrations with a registration date of a federal holiday. ***Are these valid voter registrations? Are these valid votes?***

65 REGISTERED VOTERS ON THE CLERMONT VOTER MANAGEMENT SYSTEM WERE TOO YOUNG TO REGISTER AT THAT TIME AND 44 OF THEM VOTED IN NOV 3 2020 ELECTION

While there hasn't been new voter registrations in which the registered voter's date of birth is less than 18 years old to the next election, there are 65 registered voters on Clermont County's Voter Management System who were too young to register at that time.

Clermont County Board of Elections and the Secretary of State appear to lack the necessary oversight to catch and correct these simple items.

Why did these 41 registered voters go to the effort to register or re-register with a new address and not bother to return the 'Confirmation Card' mailed to them?

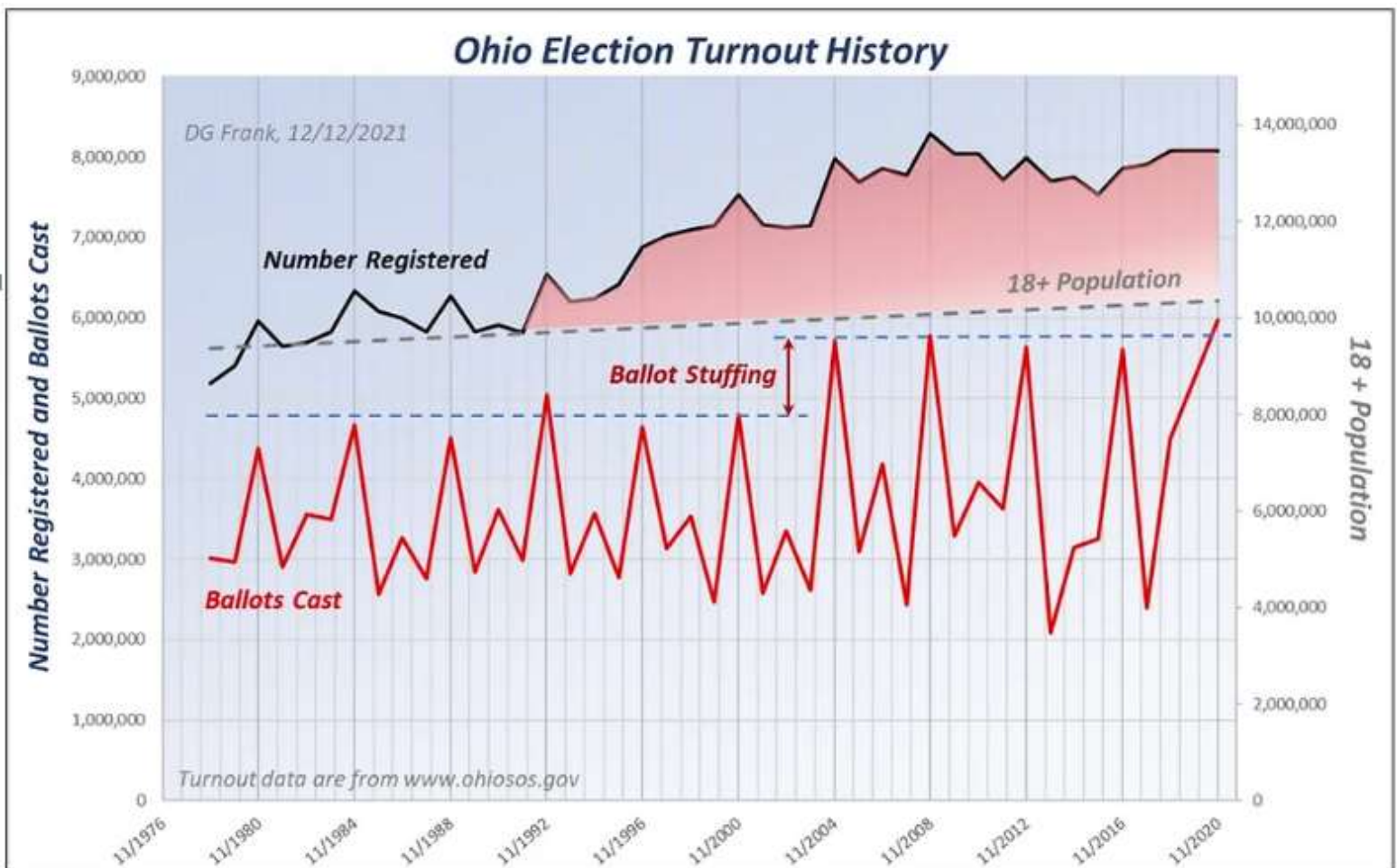

OHIO HAD ELECTION INTEGRITY ISSUES LONG BEFORE 2020

Widespread election integrity issues in Clermont County and Ohio didn't just start with the 2020 presidential election. The chart below by Ohio's own Dr. Frank shows Election Turnout History in Ohio, comparing the voting age population, number of registered and ballots cast going back to 1976. Beginning in the early 1990's, Ohio's number of registered voters began rising significantly higher than the 18+ voting age population. Then in the early 2000's, the Ballot Stuffing began where the new 'phantom voters' which infiltrated the voter registration rolls, injected upwards of 10% more ballots into presidential elections beginning and continuing through the 2020 presidential election. The spreadsheet on the following page shows how Clermont County's data closely mirrors Ohio's data.



OHIO HAD ELECTION INTEGRITY ISSUES LONG BEFORE 2020

During the 2008 presidential election, **102 precincts in Ohio had over 100% voter turnout.** There were over sixty thousand (60,133) more ballots counted in these precincts than were registered voters. This is **NOT** legal and very likely altered the results of many Ohio election races. The election results in these precincts **NEVER** should have been certified; yet the results were signed off by 102 precincts, followed by 11 counties, and finally by Ohio Sec. of State Jennifer Brunner.

Keep in mind, Ballot Stuffing is obvious in these precincts where ballots exceed registered voters; imagine all the other precincts that may have Ballot Stuffing as well, but stay under the radar as their overall ballots cast do not exceed registered voters. This explains why it is so important to have accurate voter registration rolls.

PROPOSED CHANGES TO OHIO ELECTIONS

OBJECTIVE: To restore confidence in our elections by improving election transparency, accuracy, and integrity.

OVERVIEW:

CATEGORY 1: OHIO ID VERIFICATION HAS INTEGRITY AND IS TRANSPARENT AND ACCURATE

- A) A LEGAL Ohio photo ID with proof of age, address & citizenship shall always be required to register and to vote in Ohio
- B) A LEGAL Ohio photo ID shall always be required to vote, no matter where you vote, when you vote or how you vote.
- C) A LEGAL Ohio photo ID name shall always exactly match the name listed on the voter registration

CATEGORY 2: OHIO ELECTION REGISTRATION PROCESS HAS INTEGRITY AND IS TRANSPARENT AND ACCURATE

- A) Improve the process for Ohioans to register to vote: US citizenship verification
- B) Improve the process for voters to register or update their registration, while minimizing the potential for fraud – the BMV

CATEGORY 3: OHIO ELECTION DAY HAS INTEGRITY AND IS TRANSPARENT AND ACCURATE

- A) Institute one day, one vote voting. There should be no extended voting period before or after Election Day with very few exceptions.
- B) Implement primary counting of votes by hand with machine counts only used to verify hand count. Since there is no chain of custody when voting electronically, voting machines cannot be the primary source of vote counting.

CATEGORY 4: OHIO ELECTION PROCESS FOR MAINTAINING VOTER DATA AND HISTORY HAS INTEGRITY AND IS TRANSPARENT AND ACCURATE

- A) Develop and implement a process for citizens to challenge voter registrations
- B) Eliminate the potential violation of Federal law by eliminating the ERIC system
- C) Improve the process to ensure there is only one registration per elector
- D) Improve the process and/or execution to delete voters as necessary and per law (due to change of address, death, etc.)
- E) Improve the process to create and maintain voter data and history
- F) Implement simple changes to improve the integrity of our voter registration data
